TERMS AND CONDITIONS FOR SUBMISSION OF QUOTATION FOR THE INSTALLATION OF A NEW FIRE FIGHTING SYSTEM.

1. Vendor Eligibility Criteria

- **Experience:** The bidder must have a minimum of 3 years of experience in the supply, installation, testing, and commissioning (SITC) of fire fighting systems.
- **Registration & Licensing:** Valid service providers' license from the state's Fire Services Department.
- **Certifications:** Product must be ISO certified and authorized by the Original Equipment Manufacturer (OEM) for major equipment (e.g., pumps, panels etc.).

2. Scope of Work & Standards

- **Compliance:** All works must strictly comply with the State fire authority norms.
- **SITC:** The scope includes Supply, Installation, Testing, and Commissioning of all components (fire pumps, hydrants, sprinklers, hose reels, fire alarm panels, and extinguishers).
- **Approvals:** The vendor is fully responsible for obtaining NOCs, approvals, and completion certificates from local fire and statutory authorities.

3. Price, Quotation, and Taxes

- **All-Inclusive Rates:** Quoted prices must include the cost of products, materials, labour, transportation, insurance, and all applicable taxes. GST must be quoted and billed separately.
- **Price Validity:** Rates must remain firm, fixed, and valid for a minimum of 30 days from the date of the quotation opening.
- **Escalation:** No price escalation will be entertained during and after the execution period.



4. Commercial Terms & Penalties

- **Security Deposit / Performance Guarantee:** Successful bidder will be required to submit a security deposit (typically 5% of the total contract value) soon after receiving the work order and before executing the work (for the duration of the defect liability period).
- **Liquidated Damages:** A penalty clause for delays, usually deducting 0.5% to 1% of the total project cost per week of delay, up to a maximum limit (often 10%).
- **Payment Terms:** Structured in milestones (e.g., 50% on material delivery, 40% on satisfactory installation, and 10% retention upon successful testing, handing over, and approval of authority).

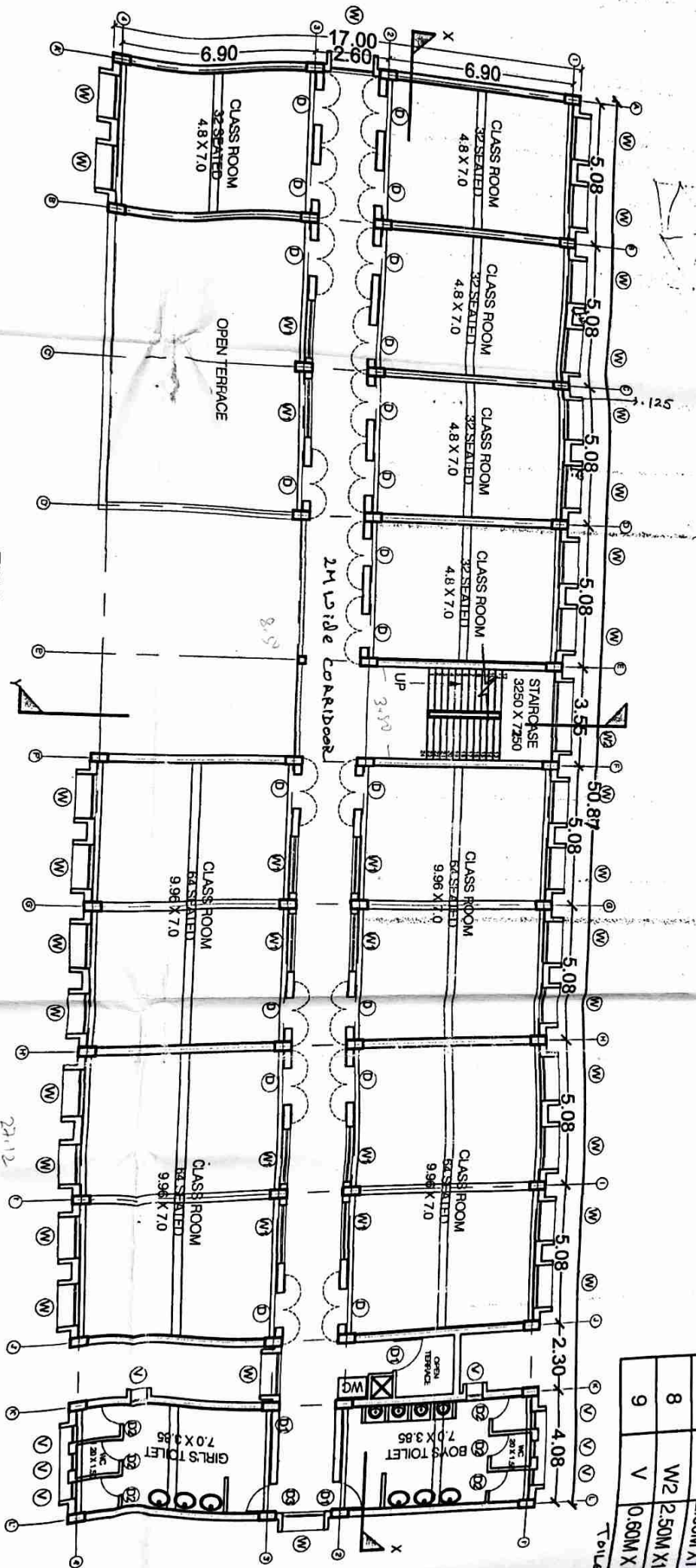
5. Execution & Warranty

- **Project Completion:** The installation must be completed within the stipulated time frame (e.g., 10 to 15 days) from the date of the work order.
- **Defect Liability / Warranty:** Comprehensive onsite warranty for a minimum of 1 year from the date of final commissioning and handover.
- **Statutory Compliance:** The service provider must comply with labour laws and other regulations as applicable.

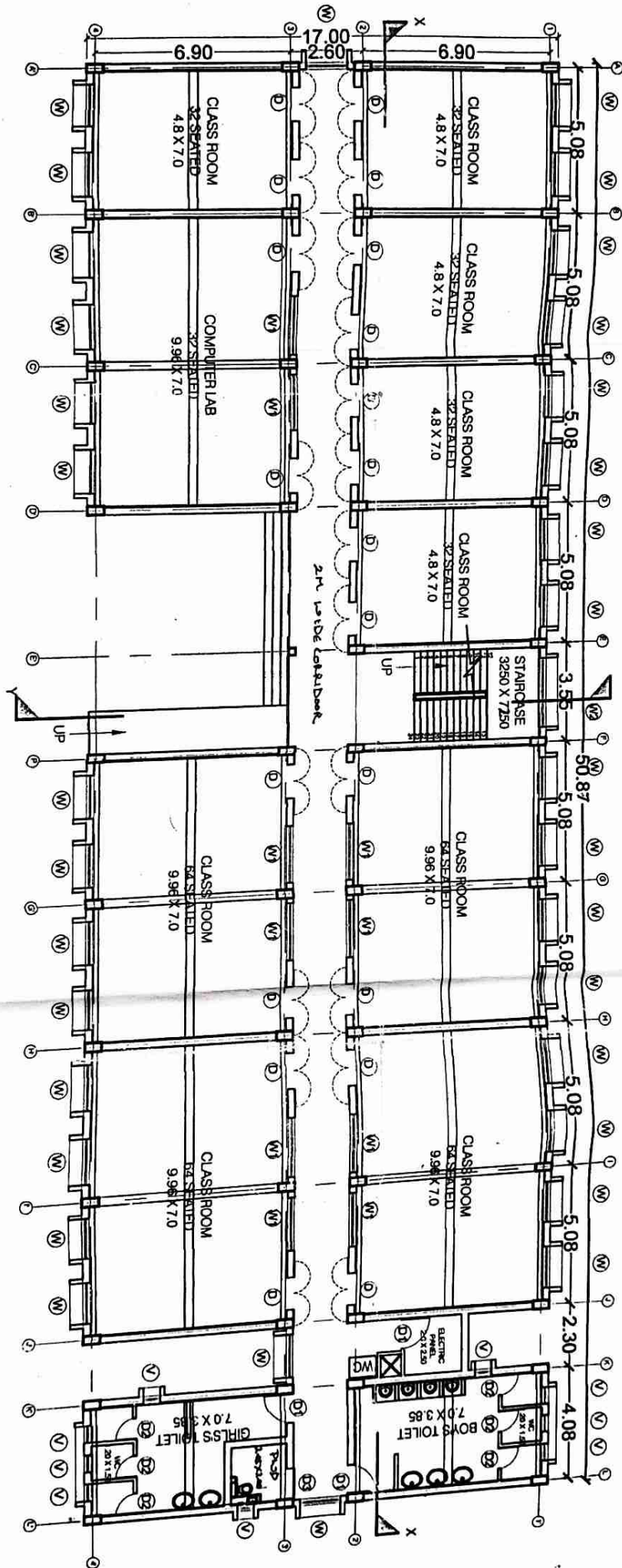

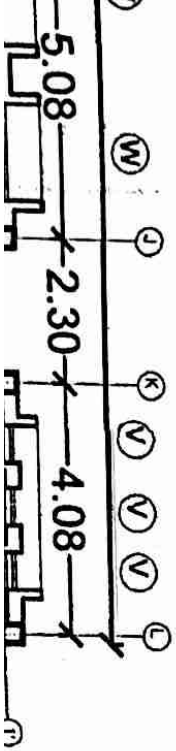


GROUND FLOOR PLAN

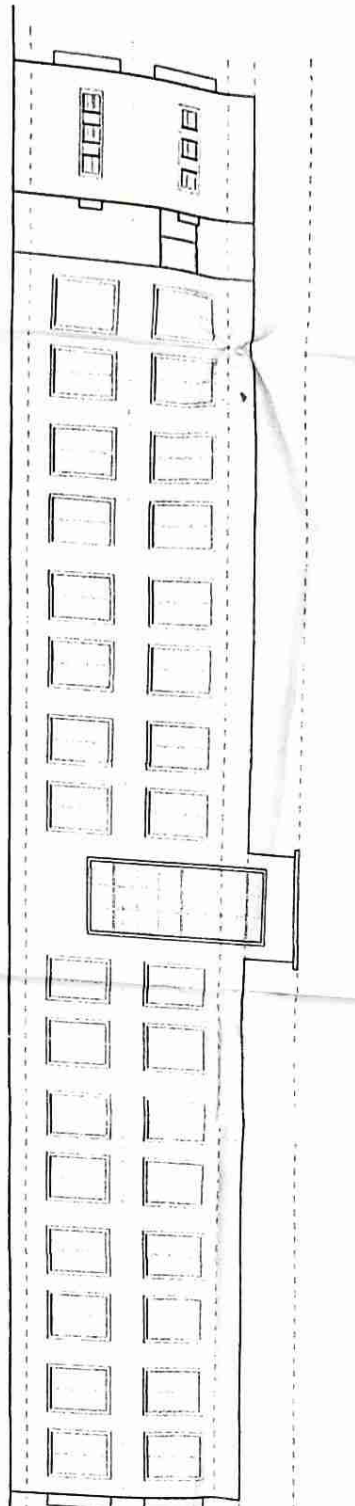
