## **OFFICE MEMORANDUM**

The State Government, after careful consideration, has been pleased to introduce 11.25% reservations for students belonging to the Socially and Educationally Backward Classes (SEBC) in admissions to all State Public Universities, State Government Higher Secondary & Higher Education Institutions and Aided Higher Secondary & Higher Education Institutions of following categories:

- I. Higher Secondary Schools (+2) under State Board/ State University, Teacher Training and Vocational Courses coming under School & Mass Education Department
- II. Undergraduate, Postgraduate, Teacher Education Courses coming under Higher Education Department
- III. Bachelor in Performing Arts courses coming under Odia Language, Literature & Culture Department
- IV. B.P.Ed. / M.P.Ed. Courses coming under Sports & Youth Services Department

Accordingly, the following uniform reservation in admission will be applicable to the institutions stated above:-

- Scheduled Castes (SC): 16.25%
- Scheduled Tribes (ST): 22.5%
- Socially and Educationally Backwards Classes (SEBC): 11.25%
- Persons with Disabilities (PwD): 5%
- Family of Ex-Servicemen: 1%

The above provision of reservations shall come into force with immediate effect from the Academic Session 2025-26.
